MYEDU OÜ & 1MyEdu OÜ BASICS OF EDUCATION ORGANIZATION

1. General Provisions

- 1.1. **MYEDU OÜ** (registration code **14682138**) and **1MyEdu OÜ** (registration code **14730280**) operate jointly under the name **MyEdu** in organizing supplementary education and adhere to the current legal regulations in the field of adult education, as well as other applicable regulations and documents.
- 1.2. **MyEdu** is an adult supplementary education institution that organizes qualification improvement courses in the following fields: **Database and network design and administration**, **Computer usage**, **Interdisciplinary information and communication technologies**, **Software and application development and analysis**, **Marketing and advertising**, **Language learning**, **Music** (Economic activity notification numbers: 220905, 258764).
- 1.3. Training is conducted **online**. The **MyEdu** training center uses its own online platform as well as **Zoom** and **Google Meet**.
- 1.4. Office premises are used at L. Koidula 38 and Poordi 1-34, Tallinn.
- 1.5. Training is conducted **in the form of courses**, and the course volume is calculated **in academic hours**, where **one academic hour equals 45 minutes**.
- 1.6. The official administrative languages of **MyEdu** are **Russian and Estonian**.
- 1.7. The main educational document is the **curriculum**, which defines:
 - the name of the program;
 - the curriculum group;
 - learning outcomes;
 - conditions for starting studies (if required for achieving learning outcomes);
 - total study volume, including classroom, practical, and independent work proportions;
 - course content;
 - description of the learning environment;
 - list of study materials (if required);
 - conditions for course completion and issued documents;

description of necessary qualifications, study, or work experience for instructors.

2. Conditions and Procedure for Admission to Supplementary Education Courses

- 2.1. Registration for courses is possible through:
 - Online form on the website <u>www.myedu.ee</u>
 - By email: <u>info@myedu.ee</u>
 - By phone: +372 58177183, +372 58818020
 - 2.2. A course **is opened** if a sufficient number of participants are registered (for **individual training**, one person). The training group size is **from 2 to 20** participants.
 - 2.3. Conditions for starting studies:
 - 2.3.1. Testing is not required.

3. Conditions and Procedure for Expulsion from Courses

- 3.1. A student is expelled from a course in the following cases:
 - At their own request, expressed in writing or orally;
 - Absence from training without notifying the reason for the absence;
 - Non-payment of an invoice for one study month.

Each case is considered individually.

3.2. The student is notified of expulsion via email.

4. Conditions for Completing the Training

- 4.1. At the end of the course, the student takes a **final written test**, assessing the achievement of learning outcomes.
- 4.2. A **certificate** is issued if the student has **participated in the course and successfully passed the final test**.
- 4.3. A **certificate of participation** is issued if:
 - the student did not achieve all the learning outcomes;
 - the final test result is below 60%.

5. Conditions for Payment, Exemption, and Refund of Tuition Fees

- 5.1. The basis for payment is a contract with the client. Payment can be made:
 - In full before the start of the training;
 - In installments (2-3 parts during the training period);
 - Monthly based on an issued invoice.
 - 5.2. Payment is made **based on an invoice**, which must be paid **by the specified due date**.
 - 5.3. **Exemption from payment** may be possible as part of **charity programs** (reviewed at a management meeting).
 - 5.4. If **two or more family members** attend the training, a **5% discount** is provided.
 - 5.5. Course fees are listed on **www.myedu.ee** and include study materials.
 - 5.6. If a participant withdraws from the course, they must notify **MyEdu** by phone +372 58177183 or email info@myedu.ee
 - 5.6.1. **Partial refund** is possible if withdrawal is announced **no later than 10 days before the start of the course** and prior expenses have been incurred (e.g., purchase of materials).
 - 5.6.2. No refund is given for non-attendance without notice or discontinuation of the course.
 - 5.6.3. The paid amount can be transferred to another course.
 - 5.6.4. **Payment is not refunded** in case of early termination of training, but for **valid reasons** (illness, business trip, etc.), the student may **continue training in the next group**.
 - 5.6.5. Training takes place **according to the group's schedule**.

Classes canceled due to **teacher illness** are rescheduled **on other agreed dates**.

6. Other Important Training Organization Conditions

6.1. Privacy Policy:

- 6.1.1. The following data is collected during registration: **name, email, phone, personal code**. Data processing is carried out **in accordance with EU and Estonian laws**.
- 6.1.2. Providing data of minors without parental or guardian consent is prohibited. In case of violation, contact us via **contact**.
- 6.2. The paid tuition fee can be **declared in the income tax return** as **education expenses** in accordance with §26 of the Income Tax Act.
